Assessment of learning outcomes need to be included. It was noted that the consultant possessed knowledge of subject matter, but lacked the academic credentials necessary to review the proposal. The institution should engage another consultant. After discussion, it was moved by Dr. Gingerich, and seconded by Dr. Castiglia, that this proposal not be recommended to the Presidents' Council. The motion carried. Christopher Capuano abstained. Action Item: The proposal will be returned to the institution so that the concerns may be addressed.

Joann La Perla-Morales read Dr. Toney's recommendation. The submitted proposal's goals are laudable and can benefit students. The consultant lacks administrative or curriculum development experience. The assessment of learning outcomes were generic, and lacked clarity regarding how student success will be measured. The institutional response needs additional detail regarding admission requirements. Dr. Baenninger concurred with Dr. Toney's remarks that the proposal needs clarification on assessment, admission requirements, and as to whether an additional faculty member with a terminal degree in MFA would be considered. After discussion, it was moved by Dr. Baenninger, seconded by Dr. La Perla-Morales, that the proposal not be recommended to the Presidents' Council. The motion carried. Christopher Capuano abstained.

The AIC is not recommending this proposal to the NJPC. The committee has reviewed the letter from Dr. Andrew Scott Ziner as the response to the issues raised in the AIC's letter of October 4, 2017. Specifially, the committee requests that Eastern International College respond to the following items:

- Engage a consultant with a background consistent with the program being proposed. (The reviewer engaged as the consultant has a degree in Business Education and no apparent experience with allied health programs).
- The consultant did not conduct an on-site visit
- The consultant did not make any recommendations for improvement or even suggestions.
- The consultant's responses to many of the required issues is based on "discussions with EIC" without reference to any direct evidence to support the issue. EIC needs to ensure that the consultant understands the purpose of the report.

- There is a very confusing statement in the curricular map, the heading says "EIC"s Nursing Program graduates will... This could simply be a typo but it lead the AIC to consider that these could be Learning Outcomes for a different program not the BSAHL.
- The proposal dated August 2017 states that a significantly revised College Mission and Strategic Plan was developed and vetted by the College administration and Board and is still in progress, pending formal approval. This pending mission and strategic plan supports EIC to exceed its current mission and expand baccalaureate programs. This appears to suggest that the strategic plan relevant to this proposal is the one pending approval and not the one approved on February 15, 2016.

The above constitute the recommendation made by the AIC. I would also like to respond to comments you made in your letter to President Levao regarding letters of support and objection. For AIC purposes there are two types of letters an institution may receive, a letter of objection and a letter of no objection. EIC received four letters of objection and approximately 10 letters of no objection. There is a distinction between a letter of no **objection** and a letter of **support**. You indicated that the AIC did not consider the letters of **support** in our decision, in fact these were letters of no objection. To say these ten programs were **in support of** your proposal is not in accordance with the AIC manual and procedures.

The AIC Committee also consider the discussion as to whether a re-submission was to be a "New Program" or a "Re-submission to be irrelevant. In either case the committee would be following the guidelines in the AIC Manual to determine the approval or nonapproval of the program.

The AIC Committee also wanted to communicate to you that the decision to not approve the proposal in its current format has nothing to do with the fact that the BASHL would be "exceeding" the mission of EIC. The AIC was not making its recommendation based on "exceeding" mission but rather on the content and quality of the proposal.

Dr. Haney moved, seconded by Dr. Connolly that the proposal be presented to the Presidents' Council for approval. The vote to not move this proposal forward was unanimous.

Action Item: The motion will be returned to the institution with a detailed report so that the committees concerns can be addressed.
